




EU strategic agenda for 2024-2029

Following the European elections in June 2024, the EU has defined **key priorities** to guide its work until 2029.







Biogases are well placed to answer all items of the Energy Trilemma.

Biomethane production could supply **85% of gaseous fuels demand**

Is Europe making the same mistakes as before?



- Europe's competitiveness
- Driving down GHG emissions
- Security of supply

- Speeding up the developments as Europe's own resource
 - Derisk investments in clean technologies
 - Establishing lead markets with biogases
 - Speeding up permitting
 - Establishment Renewable Accaleration Area's
- Circular economy and agriculture
 - Digestate to be safely used with right agronomic practices >170 kg N
 - Inlcusion of low-carbon and recycled nutrients as part of achieving
 - climate nutrality

 - Bringing together main EU experts from Regulator, country, policy, infrastructure together. Goals: Recommendation to the EC

- Joint open letter to WRI (+126 signatories)
 - Strong request for guidance notification on biomethane reporting
